

1) About the Educational Society:-

The school is being run by a private registered society called "RAVINDRA BHARATHI EDUCATIONAL ACADEMY, SATYANARAYANA PURAM, VIJAYAWADA, KRISHNA DISTRICT" which was registered under certificate of registration of societies Act XXXV of 2001 with Registration No.155/2003, dt:10.07.2003. 3) Accommodation:-

There is a pucca building with 30 class rooms to run the classes, laboratory, Library, Head Master room, Staff room, Physical Education room, Physics Lab, Chemistry Lab, Computer Lab etc. All the class room is ventilated and structurally sound. Accommodation is sufficient for all the children. Building plan and structural sound certificate is enclosed for kind perusal.

4) Play Ground:-

The management has provided 2500 Sq.Mts of land for the use of open play area. The land is located at R.S.No. 168/2 & 168/3, Kanuru Gram Panchayath. The management have registered Lease deed in the name of society vide document No: 3857/2018, Dt: 25.04.2018. Copy of the sale deed enclosed herewith.

11) Sanitary certificate:-

There are 20 urinals/lavatories for boys and 20 urinals/lavatories for girls. Separate toilets arranged for the staff. Sanitary Certificate issued by the Medical Officer, Primary Health Centre, Penamaluru is herewith enclosed. Panchayath Bore well water and tap water is being used for drinking purpose. Aqua guard facility arranged in the school campus.




